## **The QDRO Process**

**STEP #1** 

Receive & Review the Necessary Documents

**STEP #2** 

Obtain Additional Information, if necessary

**STEP #3** 

Draft the Proposed DRO

**STEP #4** 

Circulate the Proposed DRO for Review and Approval by Attorneys/Parties

STEP #5

Revise as Needed

**STEP #6** 

Request Pre-Approval from the Plan Administrator (If allowed by the Plan and requested by the attorneys/parties.)

Once we have completed Steps 1-6, our part of the process is complete.

**STEP #7** 

Obtain Signatures and File DRO with the Court

**STEP #8** 

Submit DRO to the Plan
